**Meeting Minutes for the
2022 ANNUAL BUSINESS MEETING
of the
COUNCIL OF ALLIED SOCIETIES**

Meeting Date and Time: Friday, March 31, 2022 at 10:00 am - Chicago Hilton, McCormick Boardroom, Fourth Floor, 720 S. Michigan Avenue, Chicago, IL 60605.

Meeting called to order by Steve Tomka, CoAS Chair.

Jaye Smith was asked to be the Secretary of the meeting.

The Secretary called the roll of Member Representatives, Alternates and Officers attending the meeting:

Sara Pfannkuche, Representative (Illinois Association for the Advancement of Archaeology)

Alice Berkson, Alternate (Illinois Association for the Advancement of Archaeology)

Marybeth Tomka, Representative (Texas Archaeological Society)

Steve Tomka, Chair, Council of Allied Societies

Jaye Smith, Vice Chair, Council of Allied Societies

The Secretary then called the roll of current members for the 2022 calendar year.

The Chair reminded everyone of the current meeting mask policy. The Chair read the land acknowledgement as stated in the SAA Meeting Program. The Chair stated that Leadership is committed to working on issues regarding timely membership processing and acknowledgment. He then highlighted the accomplishments of CoAS during the past year as stated in the CoAS Report to the SAA board submitted in March. The Chair highlighted the work of CoAS Newsletter Editor Belinda Riehl-Fitzsimmons.

The Chair stated that the greatest challenge CoAS faces is to find individuals who have the energy, vision and a plan to take CoAS into the future; and that all three of these key components are necessary for the continued success of CoAS.

The Chair then calls to the Floor for Officer Nominations not included in March 2022 "News and Notes". No additional nominations were received from the floor.

The Secretary announced the candidates for 2022/2023 CoAS Officer Positions. The Secretary called for a voice vote to accept the slate of officers as listed. Voice vote was unanimous for the following offers to serve one-year terms, ending April 2, 2023:

Chair: Steve Tomka

Vice Chair: Jaye Smith

Secretary: Andrew Gourd

It was recommended that the time and date of the 2023 annual meeting be changed to Saturday, so as to provide a better opportunity for local representatives to attend.

Sara stated that with limited available funding prevents many members from attending the SAA Annual Meeting and participating in CoAS Activities.

The Chair then called for new business to be presented. Jaye mentioned the possible collaboration between CoAS and the SAA Crabtree Award Committee. Jaye reported that during the Committee meeting on Thursday, the Chair and other members were very open to such a relationship, as well as involving more Indigenous candidates for the Award. Jaye will continue to liaison with the Committee and report to the members on the progress going forward.

Sara stated IAAA's desire to craft an Ethics/Anti-Harassment policy that will directly relate to archaeological societies and their members. She would like to see the policy address member one-on-one relationships with the organizations, with a key component being an open and diverse supportive group; those that do not follow the guidelines could be subject to removal from the affected organization. Sara stated that the current available sample policies are more hierarchal, hence the need to add lateral member-to-member policy.

Suggestions from the floor included creating a CoAS Working group to craft such policy; to canvass members through CoAS newsletters and social media platforms on the existence of such a policy within other member societies. Alice suggested using SAA's resources to verify the crafted policy meets legal

challenges and SAA's own code of ethics. Sara agreed to undertake the role of Chair for the Working Group; a call for additional volunteers will be included in the May newsletter. A goal of September 2022 was set as the first Working Group meeting, facilitated by Sara, through her Zoom account.

The 2023 Annual Meeting was discussed, along with the importance of including the Oregon Archaeological Society in all pre-planning for CoAS events and activities.

The Poster Contest was discussed and the success of the restructured platform allowing the public to vote on potential winners versus only voting from SAA members.

Alice mentioned that there is a need to reach public segments that are not part of regional archaeological societies. She suggested that outreach to State Archaeologists might help facilitate the outreach. Sara offered to use her connections to reach out to Iowa and Wisconsin.

Steve highlighted various ways that CoAS can bring value to its members. As examples, he cited providing speakers at society meetings, working with SAA to make their online presentations available to general memberships. Steve stressed that more must be done by both SAA and CoAS to engage societies.

Sara mentioned a poster on New Technologies in Archaeology, noting that many members are not familiar with the advantages of digital technology in archaeology and that presentations on such were difficult to present in person. Sara suggested videos on GPS operation, Lidar, drone applications and how these technologies assist volunteers in society projects would have more application to members versus the standard instructional video.

Steve mentioned that professionals are currently torn in many directions. He again reiterated that CoAS members must think about the future of CoAS once current officer terms meet term limits in 2023. He noted that the future of archaeology is going to demand a grassroots movement, starting with the regional societies, not relying on the professional community for help to move forward. Steve stated that the bulk of the "love" of archaeology comes from the avocational community.

Marybeth noted that more information should be sought from member societies on their programs that

include field schools, training seminars, etc. This information could then be shared with societies who might want to pursue more engagement. Marybeth stated there is great value in the "give back" and to share information on what "xxx society" is doing.

Steve indicated that CoAS should reach out to the member societies and canvass the council for these types of opportunities.

Steve mentioned the "age challenge" of member societies and that it is important to make students aware of the opportunities available by membership in regional societies. He stated that members need to come up with a new "hook" that will appeal to the younger generations as to the benefits of membership and engagement. Steve also mentioned that more needs to be done to publicize the various volunteer field work opportunities available through member societies.

Marybeth mentioned the successes of the numerous Texas Archaeological Societies academies, and wondered what other state societies are doing in this regard.

Jaye noted that opportunities can be highlighted in the monthly "News and Notes" email if the information is provided before the 15th of each month.

The Chair stated his appreciation to all for the good ideas discussed during the meeting. He also again apologized to the IAAA representatives for the issues per their membership renewal and contact issues. He closed the meeting that we will be starting over again for Portland!

New publication coming soon! *Points of View: A Guide to Saskatchewan Projectile Points with Indigenous Perspectives* is the go-to manual for learning how to identify projectile points found in Saskatchewan and across the northern plains.

A straightforward guidebook, it describes the various projectile point styles by name, age range, geographical range, attributes and images (line drawing and actual size colour photographs).

Unique to this publication are Indigenous perspectives on the artistry of projectile points, and the extensive knowledge system surrounding them. Making and using stone tools not only requires a deep understanding of stone material properties, but also about the animals being hunted: their physiology, ethology, and biogeography. The knowledge system connecting the artifacts to the people and to the land is also explored.

Current provincial legislation and regulations that govern archaeological heritage and the importance of respectful stewardship are included.

Gender and Power in the Ancient Andes Symposium, September 17-18, virtual

This symposium is designed to explore the relationship between gender and power among the ancient Andean cultures of present-day Peru. While many elite burials and iconography indicate that elite positions and their accoutrements were gendered male, excavations of priestess and senora (or lady) burials indicate that women held significant power among some pre-Hispanic Andean cultures, including the Moche and the Wari. These women, frequently referred to as either priestesses or queens, have received significant scholarly attention in the past 10 to 15 years. Scholarship addresses the relationship between gender and power through the analysis of material remains, human remains, iconography, and architecture. By focusing on how women constructed and performed power within these positions and their subsequent interments, this symposium will provide a timely conversation addressing the role of women and power in the ancient Andes.


Vermont's Revolutionary Past Meets Digital Future: Virtual Place-Based Education with Archaeology

May 26 @ 7 pm - 8 pm; Angela Labrador (via Zoom)

When the Vermont Archaeological Society was awarded a National Endowment for the Humanities Landmarks of American History and Culture grant in 2020, we were prepared to host 72 K-12 teachers on the shores of Lake Champlain where they would learn firsthand the magic of using archaeology to deliver place-based education to their students. Entitled "Freedom and Unity: The Struggle for Independence on the Vermont Frontier," the weeklong workshops featured an immersive program related to the American Revolution at partnering historic sites in the Champlain Valley. Enter COVID. After postponing the 2020 program, we made the difficult decision to transition to a virtual context for 2021. Then came the real challenge: how to teach place-based education using terrestrial and underwater archaeological sites fully online—and without a physical place. Learn how we met this challenge to deliver a highly-reviewed workshop that was in many ways more usable for teachers than what we would have done in person. The presentation will highlight the digital experiences we developed and how to access the content and an invitation to join our virtual excavation of Mount Independence. The SAA held [Public Archaeology Day](#) on Saturday, April 2, by inviting residents to take a self-guided walking tour. Participants began at either the Art Institute or at the Field Museum of Natural History and collected stickers at the beginning and end. The [program committee](#) faced a daunting task in programming and scheduling the first in-person annual meeting in three years. With so many concurrent sessions, each year we are grateful to these volunteers for their time and energy to fit the jigsaw puzzle together. We thank them for their work and dedication.

The 2022 annual meeting included some online efforts. All meeting registrants have access to the ePosters that were uploaded (about 50% of the presenters) and two experimental hybrid sessions. If you registered for the annual meeting, you can access the virtual components at saa2022.conventus.live until May 15.

2022 Election Results:

Daniel H. Sandweiss has been elected President-Elect. Sandweiss earned his doctorate at Cornell University and is a professor of anthropology and quaternary and climate studies at the University of Maine, Orono. His research on maritime adaptations and climate change in Latin America focuses on the coast of Peru. Both the American Association for the Advancement of Science and the Geological Society of America elected him as a fellow. He is the current president of The Honor Society of Phi Kappa Phi and also chief cooperating curator of the University of Maine's Hudson Museum. Sandweiss brings to the presidency extensive service with the SAA, including as a former director on the board, and he currently chairs the H. and T. King Grant for Precolumbian Archaeology Review Committee. This is but the most recent in a series of SAA committees and task forces that he has chaired including the Committee on the Americas, International Government Affairs, and the task force for editors of *Latin American Antiquity*.

Barbara J. Roth has been elected Secretary-Elect. Roth obtained her PhD from the University of Arizona and is currently a professor of anthropology at the University of Nevada Las Vegas. She approaches her research on the transition to agriculture in the US Southwest through household archaeology and a focus on gender. Roth has served the SAA in various ways including as the current chair of the Committee on the Status of Women in Archaeology.

Two persons were elected to the SAA Board of Directors: Anna Marie Prentiss (PhD Simon Fraser University) and Desireé Reneé Martinez (PhD University of California–Santa Barbara). Prentiss is the Regents Professor of Anthropology at the University of Montana. Her work with the SAA includes serving two terms as editor of the *SAA Archaeological Record*. Martinez is the president of Cogstone Resource Management based in California. She currently chairs the Excellence in Public Education Awards Committee and Repatriation Interest Group. Prentiss and Martinez's terms begin at the 2022 annual meeting and

extend until the 2025 annual meeting.

Albert D. González and B. Sunday Eiselt were selected for one-year terms on the 2023 Nominating Committee. González holds a PhD from Southern Methodist University. He is an associate professor of anthropology at California State University East Bay and conducts research in both archaeology and ethnohistory on the Borderlands working with Indigenous and Latinx descendant communities.


Eiselt, a former marine, earned a PhD at the University of Michigan. Eiselt is both a professor and an associate chair at Southern Methodist University and co-owner of Southwest Heritage Research LLC. Her research draws on descendant community and engaged archaeology in the US Southwest and issues of colonialism and ceramic studies.

Karen Brunso has been elected to a three-year term on the Findings Verification Committee. Brunso holds a BA from the University of Iowa and currently is the Tribal Historic Preservation Officer for the Chickasaw Nation and a tribal member. She is the current chair of the Committee on Native American Relations (CNAR) and represents CNAR on the Government Affairs Committee. Brunso and Lauren Sieg (chair, Committee on Repatriation) led the SAA's revision of the "Statement Concerning the Treatment of Human Remains."



2022 State Archaeology Celebration Poster Winners:



SAA 88th Annual Meeting
